VGEM HOA BOARD June 14, 2016 Meeting By Cynthia Williams & Tom Santucci

The semi-annual HOA Board Meeting on June 16 was called to order by President Pam LoBue. This article is an unofficial overview of the meeting and is not the Minutes. With the change in the 2016 HOA meeting schedule, the Gazette established a new feature in the form of a new section to report on all MOTIONS acted upon by the Board in their monthly open meetings. It has appeared in the last two issues and follows this overview.

Manager's Report: Our new Community Manager, Cynthia Williams, was introduced. She has been with DiLucia Management for seven years and has been in the industry since 2001. For more detailed information on Cynthia's background, read Norma Meyers article on page 7.

Kate thanked the homeowners for the many well wishes she has received since announcing her promotion and subsequent exit as Community Manager. She reported that no resales have occurred since the last open meeting. The HOA bank account balances as of June 14 are:

- Operating Account Univest Bank \$190,397.49
- Capital Reserves Merrill Lynch \$437,405.22
- Other Reserves (working capital and maintenance) Merrill Lynch – \$247,317.57

Committee Reappointments: Applications to apply (or re-up) for committee membership and leadership are due June 15th. If a resident hasn't yet signed up for a committee, they were advised to please fill out a form promptly.

Developer's Report: In the absence of the D.R. Horton Board representative, Todd Greene, Kate reported that there were four new home sales since the last open meeting. The total number of homes sold and settled is 352 with 38 homes remaining to be sold before transition.

Election Results: Bob Kennedy and Kathy Sorrell were appointed Election Judges for the 2016 Board of Trustees Elections by the Election Committee. The

Election Committee and Election Judges reported to the Board that Jeannie Eckard and Jim Lichtenwalner were elected Trustees to serve a two year term from July 1, 2016 through June 30, 2018.

Pam thanked Jim Roche and Jim Walsh for serving on the Board of Trustees and welcomed Jeannie and Jim to the Board.

For all the MOTIONS acted upon by the Board since the last Gazette, read the following article.

Board MOTIONS Acted Upon April through June, 2016

April 12, 2016 Meeting:

• **MOTION** from Jim Roche to purchase 13 round tables for the Great Room from Sam's Club for \$100 per table plus tax to replace the old wood tables, to be funded from the Social Committee's portion of the Activities Account.

Vote: 4 in favor, 0 opposed, 0 abstained Resolved: Motion carried

• **MOTION** from Jim Roche to purchase an aluminum Lateral Pull Down bar for the universal gym for \$99 plus tax

Vote: 4 in favor, 0 opposed, 0 abstained Resolved: Motion carried

- MOTION from Jim Roche to hire Courts for Sports for monthly maintenance of the Bocce Courts in June, July, and August for a total cost of \$725 Vote: 4 in favor, 0 opposed, 0 abstained Resolved: Motion carried
- **MOTION** from Jim Roche to adopt new pool rules as amended during discussion, to be distributed via email blast and hard copies to be distributed at the June 14, 2016 Open Meeting

Discussion: Pertinent changes include the removal of certain children's swim days following Memorial

Day, Fourth of July, and Labor Day; the Indoor Pool remaining open 12 months a year; one guest per household at the Indoor Pool; Residents bringing guests should provide their own chairs when needed; no one is permitted to remove cushion from pool chairs to be used elsewhere on the pool deck.

Vote: 4 in favor, 0 opposed - Motion carried

• MOTION from Jim Roche to adopt the following policy: Any suggestion to add or donate items to, or delete from, the Clubhouse must be put into a formal written proposal for the board's review. Please present a well thought-out plan that includes, but is not limited to: identifying the need for the item, the proposed location of the item, the purchase price, storage if seasonal item, the responsible party for installation and maintenance, the cost of maintenance, and all other pertinent facts.

Discussion: Kate suggested making a form to have available at the clubhouse listing requirements per this motion.

Vote: 4 in favor, 0 opposed – Motion carried

June 14, 2016 Meeting:

• **MOTION** from Jim Roche to exercise the third year contract extension option with Outdoor Décor for landscaping and irrigation maintenance.

Discussion: The Board approved this option in December of 2015 in exchange for a \$5,000 rebate on a necessary fungicide treatment. The extension has no increase to the contract price.

Vote: 4 in favor, 0 opposed, 0 abstained Resolved: Motion carried

• **MOTION** from Jim Roche to approve the installation of a horseshoe pit not to exceed the cost of \$800; \$120 of which will be funded by the Garden Club and \$680 funded by the Travel Club from funds held at OC Home Bank.

Vote: 4 in favor, 0 opposed - Motion carried

• **MOTION** from Jim Roche to adopt the revised Architectural Control Committee Guidelines and Community Rules (available for distribution on June 17, 2017 at the Manager's office).

Discussion: The Committees were praised for their dedication and hard work.

Vote: 4 in favor, 0 opposed, 0 abstained Resolved: Motion carried

• **MOTION** from Jim Roche to hire Nickolaus Construction to resurface the tennis/pickleball courts at a cost of \$11,200 per the specs on their proposal, to be funded by the Reserve Replacement Account.

Discussion: The engineer reported that the courts showed normal wear and tear. As this amenity is very popular the Board wants to keep it in good condition and prevent any injuries.

Vote: 4 in favor, 0 opposed - Motion carried

From the Community Manager Update on the Indoor Pool By Kate Walton



The Indoor Pool remains closed since October 29th, 2015. I would like to provide a summary of what has transpired since my last article appeared in the Winter Quarter issue of the *Grande Gazette*.

The HOA's attorney, • David Dahan, spoke with one of the principal •

engineers of The Falcon Group, David Chesky. In their lengthy conversation, Mr. Dahan let David Chesky know • that the Board has received many complaints about the length of the time of Falcon's due diligence process and that the HOA is not pleased thus far. Mr. Chesky understood, but reiterated that the report could not be drafted until all inspections were completed. Certain weather-dependent inspections such as the landscaping resulted in prolonging the process.

The Falcon Group has since sent the Board the proposal they were waiting for to prepare bid specifications to bring the entire indoor pool area (mechanical, structural, spa leak repair, etc.) back to working order. The Board met with Falcon to negotiate a better price. Falcon revised their quote but not nearly by the amount the Board expected considering the amount of work already performed by Falcon and the fact that they are getting so much work from the HOA. The Board is currently negotiating a better price and a more comprehensive scope of work. This should be ironed out

and Request for Proposals (RFP/bids) will be sent out very shortly.

The Falcon Group has also sent their first draft of the Transition Engineering Report and an updated Capital Reserve Report for review by management, Board members, and pertinent committees such as the Transition Committee and Clubhouse Maintenance Committee. At press time, I am still receiving feedback from these members on items we'd like to see added or emphasized. Thank you to all who have volunteered their time to deciphering this 100+ page report.

Mr. Dahan has put 6 parties on notice that are known to us as having something to do with the design, sales, construction, or installation of the HVAC system and the indoor pool area itself. Here is an update since March:

- Main Line Pools Since receiving their initial response denying any and all responsibility, they have now turned the matter over to their insurance carrier.
- Feinburg & Associates They have turned the matter over to their insurance carrier.
- Integrated Aquatics Engineering –They have turned the matter over to their insurance carrier.
- DR Horton Todd Greene has complied with Mr. Dahan's request to provide him with the original construction contract between Main Line Pools and After the Association provides D.R. Horton. estimates to fix the indoor pool, it is D.R. Horton's plan to send a letter to Main Line Commercial Pools, Feinberg & Associates and any other subcontractor who may be responsible, demanding that they fix the problems identified. Another demand is that defend, indemnify and hold D.R. Horton harmless based on form language included in all of D.R. Horton's contracts with its subcontractors. Finally, I received an email from Todd Greene in the beginning of June asking for his contractors to view the natatorium and of course immediately responded YES! It's been about a week at press time and I haven't seen or heard anything. I hope that this could be a small sign that they could potentially be willing to cooperate.
- John E. Schade Consulting Engineers Mr. Dahan received a letter from their attorneys denying any and all responsibility. Dahan responded requesting their contract with D.R. Horton and other pertinent information.
- Building Systems & Services They are not listed on Falcon's report but they identified themselves as the party responsible for consulting and selling the HVAC system to Main Line for this job. They performed a site visit in November and provided a bid to replace the HVAC system, but have not yet responded to Mr. Dahan's letter.

Thank you all for your patience as the Board seeks to have the natatorium brought back to life!

Finance Committee Report 2016 Budget Update

It is June 4th and we are five months into our budget year. Because of the due date for submitting articles for this issue of the Gazette was June 6th, the May financials are not yet available. A review of the VGEM financials through April 30th reflects a year to date net surplus of \$95,164. Operating income through April 30th was \$312,783 against expenses for the period of

\$217,122.

A net surplus at this point of the year is expected. The budget anticipated a net surplus of \$86,050 at this time of the year. A significant portion of our budgeted expenses are related to maintenance of the lawns and grounds within the Village while our income is collected monthly through the Association dues assessment. Also included in the year to date income is \$16,667 of the \$50,000 in net surplus earned in prior years and included in this year's budget.

Grounds maintenance includes cost of landscaping, water and irrigation costs and snow removal. Expenses incurred for grounds maintenance year to date totaled \$102,557. Included in this amount is \$74,676 paid to Outdoor Décor for landscape maintenance and improvements. Also included in the year to date grounds maintenance expenses are snow removal costs of \$24,843 and site electric charges of \$2,180.

Clubhouse expenses include pool maintenance and lifeguard coverage totaled \$20,476 through April 30th. Expenses normally incurred at this time of year are under budget, partially the result of the indoor pool closing.

The year to date budget included \$20,100 for the month of April 2016. April 2015 expense included \$19,759 for insurance premiums paid in April 2015. There were no insurance premiums paid as of April 30, 2016.

Professional services expense totaled \$52,667. The professional services are up because of legal fees incurred of \$12,619. The total 2016 budget for legal fees was \$12,200. Also included in professional services are the amounts paid to the Dilucia Management Company in the amount of \$40,049 year to date. The 2016 budget included \$125,280 for these services.

Administrative and other expenses totaled \$6,380 which is under budget by \$1,507.

Also included in the 2016 budget are amounts set aside for the replacement reserve and the deferred maintenance reserve. These amounts were \$55,000 and \$50,000 respectively. Monthly payments to the reserve accounts were made for these budget line items.

Our budget is designed to match revenues received to expenses incurred. As we progress into the summer months and incur expenses for landscaping, water, irrigation and recreation, the excess surplus will decline. Operating results usually reflect net deficits when expenses exceed our revenues during the summer months.

The Architectural Control Committee is in the middle of its busy season for reviewing applications. This is because the VGEM homeowners are in the middle of their busy season for starting new summer projects.

We can all save time and aggravation by following a few simple steps. There are many occasions when an approval is

delayed for two weeks or more because of missing information. Here are some suggestions to reduce delays and increase the chances of a quick approval.

Applications for landscaping, hardscaping and patio expansions require a **scale drawing**, which is a sketch of the project with **accurate** dimensions. The accurate sketch is required to enable the ACC to determine if the project meets the requirements outlined in the ACC Rules and Regulations and for Outdoor Decor to assess the possible impact on the irrigation system. This is also true for generator applications. Please keep in mind that the ACC cannot accept applications for these types of projects unless the irrigation system is turned on in order to determine the exact location of all the sprinkler heads on your property. The irrigation system is turned off in the late fall and does not get turned on again until the spring.

Applications for storm doors or shutters will be approved faster if you attach a picture of what you plan. Usually the brochure from the store will suffice. Similarly, applications for a patio awning will be approved faster if a swatch of the material is attached and applications for new garage door windows or outside lights will be approved faster with a picture.

The ACC members know that the application process can be a bother but it exists for the purpose of helping the Community develop in a way that maintains and increases property values while at the same time allowing homeowners to make changes and additions to their own property that reflect their individuality. Actually, HOAs are required by NJ regulations to have an ACC.

We do not want to become the "property police" but the ACC's second major duty is to assure that the homeowners are maintaining their property in a clean and attractive condition. On a practical basis, this means that homeowners should keep the planting beds on all sides of their homes neat and mulched. We realize that in NJ there will always be a few weeds but the jungle look is not acceptable. The outside of your house should be power washed if the walls have begun to look a little green from mold/mildew. This can especially be a problem on the shady side of your house.

The ACC has recommended to the HOA Board several modifications to the Rules and Regulations that we think will better accommodate the homeowners. Look for them in an upcoming article. In the meantime please do not hesitate to contact the office, myself, or any Committee member with questions.

Landscape Committee Update By Kathy McGeehin, Committee Reporter



At our June meeting we welcomed two new volunteers to our Committee. Sue Paulu and John Gallagher. They joined our Landscape Committee of Jim Harnett, Kathy Sorrell, Ken Tardiff, Joan Viventi, Kathy McGeehin, Joe Carluccio, John DaPrato, Fred Moderski, and Ray Viventi, Committee Chairperson.

Pam LoBue continues as VGEM Board liaison. We extend our gratitude and sincere thanks to our "retiring" member, Bill Hofmann, for his many years of service to our Community. So many times he went above and beyond to take care of a lawn issue for our Community. We miss him, his knowledge, insight, and quick response to irrigation problems but know that he will be enjoying more time fishing! Please thank Bill when you see him and keep in mind that we are volunteers, working on the behalf of you, our neighbors, saving you money and providing a valuable service.

It has come to our attention that we have missing equipment! We have rain sensors that are the property of VGEM HOA installed in the gutters of several homes. They properly regulate our irrigation and assist in making it cost effective. If you have a rain sensor that belongs to our community in your gutter, it is not to be touched, tampered with or removed. Please inform anyone who cleans or works on your gutters.

Our grass types, particularly the Kentucky blue sod in Phase II, but also the perennial ryegrass, tall fescue, and fine fescue that have been introduced to our VGEM lawns, are "cool season" grasses, adapted to our cold freezing winters and hot summers. Fertilization and our irrigation system keep these grass plants green during the heat of summer by artificially supplying nutrients and moisture, preventing temporary browning which is actually dormancy of the plant. Most likely, these brown areas of lawn are dormant grass plants which will return to green in fall. When outdoor temperature declines, the stress on the grass plants diminishes and in most cases they turn green.

Our newly sodded lawns in Phase II are entirely Kentucky Blue Grass and difficult to maintain in our climate. The lack of topsoil is a major issue as well. The lawns in Phase I are now a mix of grasses as the result of fall over seeding operations by our contractor, Outdoor Décor, over 3 years. The difference has been amazing as demonstrated in the before and after pictures appearing below. We ask for your patience and understanding as this is a process that takes time, usually several seasons. If you have recently purchased your home, please put your concerns in writing to D.R. Horton about sod and irrigation issues. We submit the Green Forms to D.R. Horton for the areas that are not yet under our control but we cannot guarantee a response. Speaking with our office

manager, the Board, and our Committee members, will not generate a response to complaints or issues, the Green Form will. Please complete a Green Form available outside the office in our Community Center. Just supply all information and drop in the white box. Unless this form is submitted there is no record of a problem and no paper trail to be acted upon. When we receive your form we act and respond to you. This takes time so please be patient. Please do not submit more than 1 form per problem as this just adds to our Manager's work load. Our community cannot afford to pay our landscape company to fix minor problems on a daily basis. If you have a geyser call the office, otherwise, no Green Form means there is no problem!

All grass suffers when soil is poor in quality and ours is lacking in organic matter. It also is severely compacted from construction of our homes and lack of proper preparation for sod. The remedy for these conditions takes many years. Aerating, application of nutrients and good mowing practices all help. Grass clippings supply nutrients by composting naturally. Fertilizer provides nitrogen to green and thicken our lawns. Potassium which is also applied improves winter hardiness. Many other nutrients are needed for a healthy lawn as well and maintaining proper PH (a balance of acidity and alkalinity) through soil testing and remediation done by our landscaper insures that they are available to the root systems of our grass.

All lawns are susceptible to diseases. There is no effective prevention as there are hundreds of turf diseases that can be bacterial or fungal in nature, and respond to the current weather conditions. There are management techniques, such as frequent, costly, chemical fungicide applications but no 'cures'. The damage is rarely so bad as to justify the expense. Often the financial cost of control applications is greater than the costs of reseeding the affected area at the appropriate time. Just as insect pests and weeds develop resistance to chemicals used to kill them, infectious fungi are equally capable of developing resistance to fungicides. Chemical treatment of turf disease is further complicated by the effects of humidity, rain, and temperatures that all impact the attempt at management.

Fortunately, we are able to control our indoor environment, our homes. Since control of the great, complex and ever-changing outdoor environment is not conceivable, perhaps we can begin to understand that the application of more chemicals is not the best tactic. We would be wise to consider the implication to ourselves and to our environment of the overuse of chemicals and the excessive use of water to have a greener lawn.

We have been made aware of problems and issues with the retention basins in Phase II. These basins are the responsibility of D.R. Horton and corrective action will be taken by them.

Please remember NOT TO MULCH our curb trees. The mulch application was done by Outdoor Décor this past spring. Too much mulch damages our trees. If you have trees planted less than 1 year ago that are dead please notify D.R. Horton in writing. Please use a Brown Form, also available outside the office in our Community Center as well. Just complete and drop in the white box.

Thank you for your help and patience in keeping our VGEM neighborhood green!

Library Notes By Annette Scaricamazza



Since 2009, the Clubhouse Library shelves have been changed from being merely decorative to a functional library and an added amenity to our Community. However,

a frequent and continuing problem has been the donations of very old books in poor condition, oversized books, textbooks, old magazines, hobby books and collections of books by the same author. This has been a problem for the library volunteers who then must dispose of or, when possible, donate books for which we have no space. For your information, the Atlantic County Utility Authority has set guidelines for the disposal of unwanted hardcover books. For hardcover books, you must remove the cover. The hardcover goes in the trash. The pages may go in recycling.

There are 11 shelves for fiction and three shelves for non-fiction. Each shelf can hold about 25 books, so a donation of many books by the same writer cannot be put out due to lack of space. There is no storage room for books to be held for later display. Books are frequently rotated out of the library to make room for new donations and to keep the library current and interesting. Drop off your donations of newer books to the Clubhouse coat room, but, at any one time, please limit the number of books to less than four written by the same author.

Magazines donated may be kept by the borrower and not be returned. There is no time limit on books borrowed, just that they be returned. Your understanding and cooperation is appreciated.

The "many" who were reported to have concerns that votes might be lost and had "mistrust" about the election process proved to have worried needlessly. This was accomplished by a great deal of attention to detail by the Election Committee as was demonstrated in two global emails to the Community.



The latter Election Committee report on the meeting regarding the drop box incidents gathered together the Election Committee (Lynnda Golin, Annette Scaricamazza, Tom Santucci), the three Trustee Candidates (Jeannie

Eckard, Jim Lichtenwalner, Jim Roche), the two Election Judges (Bob Kennedy, Kathy Sorrell) and the Board (Pam LoBue, Betty Alberts, Jim Walsh). The outcome was a unanimous opinion that the election was not compromised and should proceed as planned. The three Trustee candidates declared their confidence in the election by signing the Election Committee Report that was circulated to the Community by a global email.

On Tuesday, June 14 at 4 PM, the Election Committee and the two appointed Election Judges met in the Board Room to tally the votes. The DiLucia Team of Anne Macy, Norma Meyer, Cynthia Williams and Kate Walton were a great help in validating the ballots, opening the envelopes and overseeing the tallying process. Of the 332 homes eligible to vote, 254 or 76.5% cast ballots. The Committee extends thanks to Bob Kennedy and Kathy Sorrell for their participation as Election Judges. Last and far from least, our sincere appreciation to Kate who has be an invaluable resource to the Committee.

The Election Committee will be meeting to review and discuss this year's election process. With the opening of the outdoor pool and input from the Rules Committee, the Board issued a four-page VGEM Pool Rules document. 
Hazardous Waste Disposal



ACUA accepts hazardous waste material bi-monthly at the ACUA Haneman Environmental Park, 6700 Delilah Road, Egg Harbor Township. Hazardous waste disposal is from 8 AM to 1 PM on July 9th, September 10th and November 5th.

Bring proof of residency such as a tax bill or drivers license. Also, bring your items in a throwaway or recyclable container (such as a cardboard box). Containers will not be returned. Individual container sizes cannot exceed 5 gallons and there are no exceptions. The maximum quantity of household hazardous waste is 20 gallons in liquid or 200 pounds in dry weight per household per person. NO materials from commercial establishments will be accepted. You will <u>not</u> have to exit your vehicle.

Examples of disposable items: propane cylinders (one pound ONLY), 12-Volt batteries (for cars and boats), all cleaning products (glass cleaner, allpurpose cleaner, bathroom cleaner, etc.), anti-freeze, auto care products, fertilizer, fungicide, pesticides, oil based paint, etc. Items not accepted include asbestos, electronics, ammunition, infectious waste, etc. For a complete list of materials see ACUA web site: <u>http://www.acua.com</u>.




The "*Sew & Sews*" continue to meet every Wednesday morning at 9:30 AM in the Crafts Room. We are happy to announce we have several new members.

Do You Miss Growing Your Own Vegetables?



There is a solution!

VGEM Rules do not permit residents from growing vegetables. Life without your own tomato plants is a hardship for many especially since Reeds Farm closed last year. Well if you miss growing your own vegetables there is a solution, it is the "Community Teaching Gardens" at the EHT Historical Museum on West Jersey Avenue.

At the Community Teaching Gardens, there are 10 full sized plots which are approximately 10' x 20'. In addition there will be one to two smaller raised beds that are wheelchair accessible. The paths between the gardens are accessible by all community garden members.

Garden plot memberships will be available to residents of Egg Harbor Township who are at least 21 years of age. An application will have to be submitted including intent of plot usage, maintenance and distribution of food and flora grown. The number of plots is limited. The Greater Egg Harbor Township Historical Society (GEHTHS) will determine memberships based on need and intent of usage. The \$25 Membership Annual Fee helps cover any overhead costs of the garden and includes a membership to the GEHTHS Museum.

Don't be scared off by the wordy application. Simply growing vegetables to eat is an approved reason for joining the garden. It may be late for this year but think about it for next spring. Additional information is available at <u>www.gehthsmuseum.org/garden.html</u>.



Here Comes "The Donald"! Is he an opportunist or a visionary?



or a visionary? By Sydney Yacovelli Reprint from the Grande Gazette

January/February 2014

Like Cleopatra floating down the Nile on her grand barge, Donald Trump came to Atlantic City sailing into the Frank Farley Marina on his new toy, the *Trump Princess*. Hundreds of people including politicians, reporters, TV cameras and the

paparazzi all huddled in the light rain to see the New York real estate mogul standing on the bridge of the newly renovated \$30 million dollar six deck 282 foot yacht, bought from Saudi Arabian arms dealer



Adnan Khashoggi when he fell on hard times after Iran Contra, make his grand entrance to his second casino. The city viewed Trump's purchase of The Castle property from the troubled Hilton Corp. who had been denied a gambling license due to alleged mob ties, as another rebirth of the once again struggling city. Trump obtained a \$325 million dollar loan to purchase the already built Atlantic City Hilton in 1984 and opened it in June of 1985 as The Trump Castle (renamed the Trump Marina in 1997). He was now a prince among investors by owning not one, but two casino properties in the city. Trump had now positioned himself as a major player in Atlantic City after being shut out of purchase for years. He had lost out on the early easy money to be made along the Boardwalk, but he jumped into the deep end now with both feet.

How did Donald Trump at the age of 39 get to the top as a developer and owned of major real estate holdings in New York and New Jersey? He was not self made. He stood on the shoulders of his father who was himself the stuff that "genuine legends" are made.

Trump's father, Fred C., was a son of German immigrants, Frederick and Elizabeth Drumpfs, who unsuccessfully opened hotels and restaurants before



beginning a real estate business in Queens around the turn of the century. Frederick died young leaving 11 year old Fred fatherless. With a name change and a lot of work and struggle, Elizabeth Trump raised her 3 children alone. As the oldest Fred took jobs as a laborer in the building industry to supplement

the family income. By the time he was out of high school, Fred was self-employed. His first company was

"Elizabeth Trump and Son". Still even too young to sign checks himself, his mother had to sign for him. His first project was a single family home in Woodhaven in Queens. From there more homes were built; everything from mansions to blue-collar apartment buildings. By 1938 Fred C. Trump had built thousands of units and was being called "The Henry Ford of the home building industry". Later, by the time his son Donald was out of prep school and graduated from the Wharton Business School in Philadelphia his father was New York City's largest landlord and it was all his with no partners. Fred was tall with square shoulders, always well groomed, known to be intensely competitive, savvy, pragmatic and well-connected... maybe, even ruthless. All traits young Donald took note of and made his own. Donald worked with his father when not in school and learned fast the wavs of the cut throat real estate business in New York. He became president of his father's organization in 1974. Fred continued to have a large roll in the operation and in his son's life until his death in 1999 when he died from Alzheimer's.

At the time the first door opened for Donald Trump to get into Atlantic City, the city was happy for him to bring some glitzy glamour and more important, increased national visibility to the city. He had been looking for an opportunity to buy into the casino business and finally the opening came in 1980 when again someone's bad luck became his good fortune.

It had been years since much development took place in Atlantic City and constructions jobs were hard to come by. Robert Maheu, an associate of recluse Howard Hughes, and partner Grady Sanders, Pres. of Network One Inc., had a project on the books to build on the boardwalk lot next door to the Convention Hall. It would be a 1,000 room hotel casino and cost \$100 million to build. The SEC steps in with charges against Maheu and Sanders for making "false and misleading statements" of the companies' assets when filing for a gambling license and all financing dried up for the pair. Trump sees the opportunity that permits him to get into the game cheap. Trump makes a deal with Holiday Corp. in 1982 to provide the financing and to manage the casino hotel and all Trump had to do was build it and turn over the keys.

In exchange for getting it built on time, "The Donald" would receive one-half of the profits. Trump Plaza was born and Donald owned his first casino on perhaps the best location in Atlantic City.



Lighting strikes for the third time when "*The Donald*" is able to seize the moment...The Taj Mahal. The Taj Mahal was Resorts International owner, Jim Crosby, dream hotel. In order to build it, Cosby raised money by

selling shares of Resorts, which were brought by Trump. Owning stock in Resorts put Trump at the 3 casino state imposed limit of casino ownership. When Cosby died unexpectedly in 1986, Trump convinced his heirs that he could finish building Cosby's dream. This meant that Trump had to either close or sell Resorts. At this point TV personality, Merv Griffin moves in. There was a struggle for control of Resorts between Trump and Griffin, but in the end both got exactly what they each wanted; Merv got Resorts and "*The Donald*" built the Taj Mahal. But at what cost?

Cosby's dream had become a money pit by the time Trump took over. The promise that The Taj Mahal casino would "be the 8th wonder of the world" was not looking that good. An opening date of spring 1990 was set and Trump went to work to make it come in on time. The grand opening was befitting all the hype when Donald Trump rubbed a over sized magic lantern that stuck-up the marching bands and started shooting laser beams with giant fire-woks.

From down the boardwalk, the building looked like a frosted wedding cake incorporating several styles from the Regency Pavilion at Brighten Beach, England to St. Basil's Church in Moscow and a little Miami Beach added for good measure. Inside was over the top with the addition of more than 400 luxury suites, a 1,500 seat theatre and a dozen restaurants that could serve 13,000 people food at one time. The construction took enough steel to build five Eiffel Towers. In all it sat on 17 acres of land and was decorated with a two year quantity of Carrara marble. The chandeliers alone cost \$15 million. Another \$4 million was spent for uniforms for the 6,500 employees. At the time it was the largest casino in the world. To some it seemed vulgar to others... beautiful.



The construction debt was over \$1 billion. To meet daily operating expenses the casino had to take in \$1 million a day. The success of the Taj required a boatload of cash. There were concerns if Atlantic City could support a massive casino like the Taj. Where would the gamblers needed to spend that kind of money come from? Donald already had a no interest

loan from his father to meet expenses. Then one day Fred C. Trump drove up to the front door of the Taj in a sleek black limo with a very large suitcase that was full of cash. Fred exchanged the cash for \$3.5 million in gambling chips.... never used. But was that enough?

Atlantic City has had its ups and downs and surely has been full of colorful characters. The saga goes on and the struggle to keep the city's head above water never ends.

I had a brief conversation with Bill Giannetti the other day. His story must be like many others who become a USA Pickleball Association (USAPA) Ambassador. He plays tennis. He met a couple of guys, Stan Shumaker and Dave Wheeler, who introduced him to pickleball in Pennsylvania. Stan learned about the game when he visited Arizona about 5 years ago. They all gathered on the tennis court and taught Bill the game. Stan works for the City of Philadelphia so he had great connections to promote pickleball in the community.

Bill lives in a 55+ community and he got pickleball started there. Now there's about 20 folks who turn out every day to play. In the township, they're allowed to play once a week in the community center. There's a meeting soon to see if they can play in the gym, which means they can set up 4 nets for more participation in his clinics. Bill loved learning about the game, so, it seemed only natural that he would become a USAPA Pickleball Ambassador. Bill got a grant from the USAPA for two portable net systems and started introducing the game out in a parking lot. In New Jersey, he first got permission to play in an elementary school once a week. In the summer, Bill and his friends tape pickleball lines on tennis courts and play a couple of times a week.

Bill gives regular clinics throughout the year. With one or two nets, he can include 12 folks in his clinic, but

4 courts would be perfect. He plays in Ocean City, NJ as well. There are about 30 folks who play there regularly 3 times a week. Bill still plays tennis with his wife on Saturdays, but you'll find him playing pickleball Monday thru Friday now. On August 26, 2015, there was a dedication for the opening of new pickleball courts. Egg Harbor Township Parks and Recreation held a ribbon cutting ceremony for the courts located in Delilah Oaks Park. They are open to the community from sunrise to sunset.

Bill has been invited to give a clinic in Vineland, NJ, and that's how he spreads the good news about pickleball. Bill has also been asked to consider becoming a Regional Ambassador. Since he's well known in the area already, it wouldn't be a stretch.
